**G. Employer Labor Condition Statements**

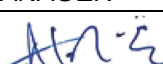

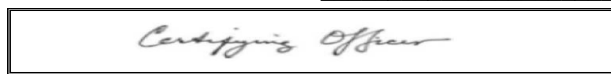
